6. **Retention of Student Status (A1.1.a.i.1.a.)** – Samuel McLoughlin to speak

*Simple majority to pass*

b. **Sibby O’Grady (Pembroke):**

We are applying to extend Sibby’s student status because her case is one of extraordinary circumstances - a term we do not invoke lightly. Last term, her health severely declined, necessitating a prolonged hospital stay, an ordeal for any student both physically and emotionally. The repercussions of her illness, compounded by the separation from her support network of friends and the cessation of all her usual activities, have exacted a significant toll on her well-being.

Both the college academic director and the welfare lead, recognizing the severity of her situation, have strongly recommended that Sibby’s student status be extended. Rowing is a cornerstone of Sibby’s recovery and reintegration into academic and social life at Oxford, before she resumes her studies next academic year. The boat club has been a central part of Sibby’s support network - she was a dedicated novice in her first year, women’s captain in her second, and treasurer this year. Until recently, she had been unable to train since last November, so there is no question of gaining an unfair competitive advantage.

Maintaining her connection with the boat club is paramount to Sibby's mental and physical health. As she resides in Oxford, full participation in the club’s activities is critical as she navigates through this challenging recovery period. While we are mindful that the policy of allowing suspended students to maintain their student status is reserved for use in exceptional cases, it is precisely for such instances as Sibby’s that this provision exists.

It was briefly explained that the difficulties with the Godstow river status flag had resulted from a change in staff at St Edwards School (SES), whose boathouse hosts many of the OURCs clubs on that stretch, prior to the start of the current academic year. While the previous, long-standing SES boatman had been happy to provide OURCs with information with which they could then set the flag, their departure had meant that the Godstow flag had defaulted to being set according to the Environmental Agency stream warning boards for the reach. Unfortunately, due to the lower section of the reach, closed to clubs in higher stream conditions, being much narrower than the top part, the EA boards for the reach are some of the most conservative along the length of the Thames. Hence, following the EA advice not to navigate the reach on Red Boards prevented crews from rowing sooner than on almost all other reaches.

The motion was presented as the result of lengthy discussions with the SES boatmen, who were willing to provide OURCs with information on when they allowed their own crews to row on EA Red Boards. The proposal broadly followed SES's own policies, with steadily more experienced crews required as the stream increased. It was explained that, although the SES requirement for coxed eights to be used on EA Yellow Boards, as well as the requirement for those boats to be accompanied by a launch, only applied to crews boating from SES facilities, the University authorities thought it best if the rule also applied to the small number of clubs boating from elsewhere. The simpler rules and closer resemblance to the flag rules for the Isis stretch were seen as particular advantages. Both the OURCS Secretary and Sabbatical Officer broadly agreed with this view, though explained this could potentially be up for negotiation and that they would

happily pass on any petitions from the captains to the University authorities if captains thought it worth trying to convince them otherwise.

The proposer also distributed an amendment to the motion [ Appendix B ], which they explained contained some small tweaks, felt to be fairly minor, and only finalised on the day of the meeting.

The captains voiced some frustration at the process that had led to this motion, feeling that there had been very little communication from the University authorities throughout. It was pointed out that the position of OURCs Captains' Representative to COUR (the Council for Oxford University Rowing) remained vacant, and it was resolved to hold elections for the role at the end of the meeting.

A number of Godstow clubs suggested alternative methods that might be used to set the flag, such as the reading of the weirs at either end of the reach, or models based on data from the stretch. Some of the models were recognised to closely follow reality, if susceptible to issues in the data used and not completely without error. As far as reading the weirs was concerned, OURCs stressed that Osney was no longer readable due to a hydroelectric scheme having been installed some years ago, and that they understood one of the Godstow weirs to not be readily readable and feared neither of the Godstow weirs were readily accessible from central Oxford. Rather, the SES boatmen were much better placed to advise on conditions on the reach.

The possibility of using measurements from flow stations, even if they were not on the same reach, was discussed, believed to be common practice amongst many non-Oxford clubs. However, while it was said to appear broadly accurate, concerns were raised at the distance to the nearest EA flow stations and the amount of water that might join the river in between them. The installation of an EA flow meter on the reach itself was felt to be prohibitively expensive, with a quote of circa £40,000 having been provided some years ago.

OURCs stressed that the motion under discussion was the only option presently on the table, the alternative being the continuation of the more restrictive system for setting the flag that had so far been in force that year. Many captains, however, questioned the usefulness of being allowed out on EA Red Boards if a 'Senior' status cox was required, since there were few such coxes. Clubs also believed a further loosening of restrictions might be possible if they were allowed to discuss the matter with SES directly, stressing that they understood the terms of their racking contracts to be an agreement between themselves and SES, without need for outside involvement. It was questioned whether an OURCs river status flag was even necessary given that OURCs member clubs rowed on several other stretches of the Thames, besides Godstow or the Isis, which were not covered by such a flag.

Ultimately the captains concluded it would be better to delay moving away from the current system in the hope that an alternative solution might be found.

The meeting voted on whether or not to accept the proposed amendment [ Appendix B ]:

9. **Addition to the Rules of Racing: Definitions (in red)** – Finlay Jordan to speak

*Two-thirds majority to pass*

A1.1.

- d. To apply for Summer Eights 2024 only. Anyone who was classified as either a Student Member or Fellowship Member, as defined in A1.1.a.i. and A1.1.a.ii. respectively, on the 28/02/2024 (first planned day of Torpids 2024), shall have their status extended up till and including the 25/05/2024 (last planned day of Summer Eights 2024), making them eligible to race as full members of their college boat club. This clause (A1.1.d.) will expire automatically on 26/5/2024, after which this clause will be removed from the Rules of Racing.

*Seconded: Matthew Campbell (Brasenose)*

With limited water time so far in the academic year and both the novice regatta and Torpids cancelled, the proposers explained that they wanted to give those who had completed their degrees in the intervening period the chance to race bumps one last time. They also suggested that it would likely be safer for more experienced athletes to compete in the crews they had been training with rather than in the lower boats to which they would be relegated as associates, since it would keep athletes in approximate speed order, as it were.

It was countered that Summer Eights had always been oversubscribed and this measure would mean displacing current students who now might not get the chance to race. While some athletes would always miss out, the student/non-student division was suggested to be the clearest dividing line when deciding who to prioritise. Furthermore, it was pointed out that the division of athletes into 'full members' and 'associates' was an old one, resulting from clubs largely being funded by their colleges, who wanted reassurance that current members were being prioritised. Associates could still compete in bumps, if only in lower boats.

Some concerns were also raised at the precedent that might be set, particularly since the cancellation of Torpids due to unfavourable stream conditions was a fairly regular occurrence, though this was recognised to be of little comfort to those on short degrees who had the misfortune to be students this year.

Ultimately, while a sizable section of the captains felt, given the apparently limited number of athletes affected, that it would be an act of kindness to those former students to pass the motion, another section remained that did not see the circumstances as sufficiently extra-ordinary to warrant a change to the rules.

#### 10. **Isis Winter League Victor Ludorum Presentation** – Sophia Ungermann to speak

Wolfson CBC were announced as the overall winners of the Isis Winter League races 2023-24 and presented with the IWL Victor Ludorum Shield.

Mansfield CBC received an honourable mention for topping the Women's Leaderboard and coming a close second to Wolfson in the overall rankings.

#### 11. **Isis Winter League Fines Award Presentation** – James Hopkinson to speak

St Peter's CBC were announced as the proud winners of the 'Largest Contributor to IWL Fines' title for 2023-24, while also taking home the much-coveted 'Biggest Fine from 1 IWL' award.

#### 12. **AOB**

- **Treasurer's Report** [ Appendix C ] – James Hopkinson to speak

The Treasurer highlighted some details of the report. It was noted that a loss had been made on Torpids, despite its cancellation, since OURCs had to pay a cancellation fee for the medical cover.

The return of the Summer Eights programme was discussed in some depth, with bulk pre-orders via individual clubs being highlighted as an excellent way for people to guarantee a programme. It was stressed that the programme would have to go to print at, or likely even a little before, Close of Entries. Captains were therefore strongly encouraged to get their crew orders in well in advance, though an email would follow with specific details and deadlines.

While OURCs had purchased a card reader in order to help sell the programme, the purchase had only been made earlier that day so was not included in the report.

- **Invitation for MNR Bids** – Qianyi Sun to speak

Captains were encouraged to read the bid guide circulated earlier that day. While the deadline was still well over a month away, committees were encouraged to start discussing any potential bids as soon as possible.

- **Election of OURCs Captains' Representative to COUR**

Only one candidate was nominated for the role, Robert Doane-Solomon of Pembroke.

- **Bank Riding Safety Reminder**

The captains were asked to remind their bank riders of the need to cycle safely on the towpath, giving sufficient attention to the path ahead and other members of the public. Cyclists must give way to pedestrians (and persons on horseback). They should not be using any hands to film crews whilst cycling, or do anything else that may prevent them from paying due care and attention to their cycling. If they are involved in a collision, cyclists must stop to provide assistance and/or information as necessary.

During racing, clubs whose bank riders do not follow this will be fined.

# Appendix A

## OUBC Women's President Report: April 2024

### Introduction

Since our last meeting in January, the Women's Squad of Oxford University Boat Club has experienced a productive and eventful three months. Our efforts in recruitment, training, and competition have yielded significant successes, demonstrating the commitment and talent within our club.

### Recruitment and Training

- **Recruitment Efforts:** We undertook extensive recruitment efforts before the January Masters deadlines, resulting in a high number of applications, particularly from National Training Centre Athletes.
- **Performance Milestones:** Our club celebrated numerous Personal Bests (PBs) and set a new club record in the January 5k.
- **Caversham Lakes Seat Racing:** We had the opportunity to use Caversham Lakes for seat racing in early February, a valuable process for our team.

All crews must be accompanied by a launch. The river is closed below Rainbow Bridge, crews should spin no lower than the sailing club unless landing at the Keble yard. Navigation of Osney Lock is prohibited.~~
- i. Red Flag (at the discretion of the St Edward's School boatmen when the EA display Red Boards for the Godstow to Osney reach): the Godstow stretch is closed to all crews. Navigation of Godstow and Osney Locks is prohibited.

- ii. Amber Flag (at the discretion of the St Edward's School boatmen when the EA display Red Boards for the Godstow to Osney reach): the Godstow stretch is closed to all crews except eights classed as Senior crews, as defined in [2.7](#). All crews must be accompanied by a launch. The river is closed below Rainbow Bridge; crews should spin no lower than the sailing club unless landing at the Keble yard. Navigation of Godstow and Osney Locks is prohibited.
- iii. Dark Blue Flag (EA displaying Yellow Boards for the Godstow to Osney reach): the Godstow stretch is closed to Novice crews as defined in [2.7.c](#), and all boat types except eights. All crews must be accompanied by a launch. The river is closed below Rainbow Bridge; crews should spin no lower than the sailing club unless landing at the Keble yard. Navigation of Godstow and Osney Locks is prohibited.
- iv. Green Flag: no additional restrictions in force.
- v. Grey Flag: the system is not currently being maintained and all crews are responsible for referring to the EA or lock keepers for stream advice.
- vi. In circumstances where information from the St Edwards' School boatmen is out of date and the stream is flowing faster than it indicates, the flag may be changed upwards by any member of the OURCs committee, as long as the decision itself has been taken by at least one of the Secretary, Captain of Coxes, or Rowing Sabbatical Officer, and if possible by all three in conjunction.
